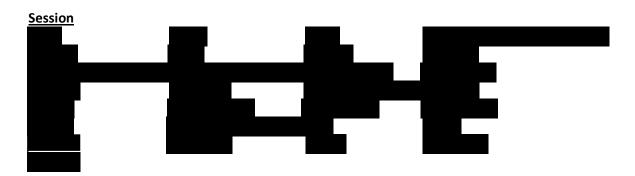

Structure, Governance and Management

Governing Document

The Church is administered in accordance with the terms of the Deed of Constitution (Unitary Form).

Recruitment and Appointment of Trustees

Members of the Kirk Session are the charity trustees. The Kirk Session members are the elders of the church and are chosen from those members of the church who are considered to have the appropriate gifts and skills. The minister, who is a member of the Kirk Session, is elected by the congregation and inducted by Presbytery.

Organisational Structure

The Kirk Session meets six times a year and is responsible for both spiritual and temporal matters within the church.

Objectives and Activities

The Church of Scotland is Trinitarian in doctrine, Reformed in tradition and Presbyterian in polity. It exists to glorify God and to work for the advancement of Christ's Kingdom throughout the world. As a national Church, it acknowledges a distinctive call and duty to bring the ordinances of religion to the people in every parish of Scotland through a territorial ministry. It co-operates with other Churches in various ecumenical bodies in Scotland and beyond.

Achievements and Performance

We continued to hold in person worship every Sunday in Dunbarney and Forgandenny Churches at 10.30am on alternate weeks. Coffees and teas were on offer for further fellowship after both church services. Services were streamed from both Sanctuaries for those unable to attend in person, there is also a telephone service allowing people without internet connection to have access to services too.

There were regular monthly services at the Earnbank retirement development and regular school assemblies at Forgandenny and Dunbarney Primaries, with those at the end of each term held in their local Sanctuary with many parents and carers present.

The Perth Presbytery Plan was approved in June and readjustments were discussed at length, with our linkage with Aberdalgie and Forteviot agreed in late October. Over several weeks at the beginning of the year we held Zoom discussions with interested people from all the Lower Earn churches, working our way through 'The Bible Course'.

At Communion, on the first Sunday in December, worship moved to 11.00am as this was the first Sunday that Rev also conducted worship at the linked charge of Aberdalgie and Forteviot at 9.30am. These timings will continue until the linkage with Abernethy has been set up in Spring 2024.

Four Communion services were held throughout the year on the first Sundays in March, June, September and December as well as the usual celebrations at Easter, Harvest Thanksgiving, Remembrance and Christmas. Events like the 7.30am breakfast service at Easter and the Big Sing at Christmas were enjoyed by many, as they were reintroduced now that people feel more relaxed post-Covid.

The successful Advent Trail held throughout December finished in a packed Dunbarney Church on Christmas Eve, this was very well attended by families from the local community.

Church organisations continue to flourish with three keep fit sessions on a Monday, monthly soup lunches, the Banner group on a Tuesday afternoon, the Women's group once a month, a Youth Drop-in for P7 to S3 on a Wednesday evening, Chatterbox for the under threes and the Cosy Spaces lunches every Friday. Towards the end of the year a chair keep fit class was introduced before the lunch on a Friday. These were all well attended by church members and people from the local community. The church hall at Dunbarney is well booked up every week with those and other events like yoga, RVS lunch club, bowling, bridge, Earn singers, meetings, celebrations and funeral teas. However, the Monday Club committee met in 2023 and decided they could no longer continue with the group, so their remaining funds were distributed amongst local charities (including the church).

The work of the pastoral group, shawl ministry and the flower ministry continue to support both church members and those in the community that are known to us.

Cosy Spaces funding from PKC has allowed Dunbarney and Forgandenny Church to support the Bridge of Earn Baby and Toddler Group, the Wednesday games afternoon in the Bowling Club, the keep fit and lunch on a Friday and entertainment events in the church followed by refreshments in the hall. In August Cosy Spaces changed its name to Warm Spaces where the focus was more on encouraging fellowship and a space to meet and, again, we had a successful application for funding to continue to support all of those initiatives which were well attended by people from our church and community. We were also able to pay the local social-enterprise café, Giraffe, to provide the soup and home baking on a Friday.

Social events throughout the year have included gentle walks ending with coffee and treats, a quiz evening (in aid of Christian Aid), a volunteer thank you coffee morning and in September an all-day event celebrating 100 years of Dunbarney Church. Exhibitions from many local groups, food, games, stalls, lots of photographs and a 'through the century' quiz. It was packed with locals and the atmosphere as folk reminisced was amazing and made it a very happy day.

Rev has conducted 26 funerals, 2 baptisms and 3 weddings throughout the year.

The Parish Voice was distributed three times last year to all members and adherents, Christmas cards were delivered to everyone in the local communities of Bridge of Earn, Oudenarde and Forgandenny. An extra Parish Voice was delivered in October to explain all about the proposed linkage with Aberdalgie and Forteviot and the vote that needed to take place.

Online donations for charities have continued to be encouraging throughout the year. Those, and physical donations have supported Jars of Grace, Christian Aid, the Scottish Poppy Appeal, CATH, Perth Food Bank, Shelter and the Stroke Unit at PRI. Members of the Church family also arranged the usual collection of required items for the Blythswood Shoe Box appeal.

Our Facebook page and our website are regularly updated with 'what's on' locally as we seek to work to our Mission Statement 'A place of Christian Worship and Outreach and a Hub for Community enabling people to connect with Jesus and one another'.

Financial Review

We continue to benefit from the majority of our supporters making their offerings electronically, either by Standing Order or through Donorbox from the Church website. Due to increased in-person attendance at worship, we have seen an increase in cash donations this year. However, overall general donations in 2023 were approximately £2,300 less than in the previous year (£81,438 in 2023 vs £83,814 in 2022), although the Gift Aid recovered was almost identical to the previous year (£51,831 in 2023 vs £51,784 in 2022).

We were very fortunate to again be the recipients of grant funding to allow us to continue running our 'Cosy Space' project. We received the sum of £7,294 from the Perth & Kinross Council Warm Welcome Fund, which will see us through to the spring of 2024, and will allow us to extend our collaboration with the Bridge of Earn Baby & Toddler Group. PKC have also provided funding for our Youth Drop-in, with £13,500 received from their Community Investment Fund. This should be spent by May 2024, with any under-spend to be returned to them. The funds received in 2022 to support 'Cosy Spaces' and ease the pressure of the cost of living crisis (PKC Community Fund, National Lottery Community Fund and Cameron Group Charitable Trust) were all spent in full within the year.

The refurbishment project gathered pace in the course of the year, with outgoings totalling £20,667 (£3,890 in 2022). The dedicated fundraising day in September 2023 provided a boost of £3,323 after running costs had been covered. We closed the year with a balance of £8,021 in the designated project account. As required, funds will continue to be transferred from our general fund, with further funds to be drawn from the Investor Trust and General Trustee accounts as the project progresses throughout 2024. Our hall continues to be a very well used facility, with several regular bookings in place – income from hall bookings increased from £2,295 in 2022 to £3,790 in 2023.

The Church of Scotland 'Ministries & Mission' scheme was replaced with 'Giving to Grow' in 2023. The contributions of £51,054 are our largest expense. This amount was £2 higher than our Ministries and Mission contributions in the year 2022.

Reserves Policy

It is the Trustees' policy to hold cash reserves of approximately six months' expenses (excluding designated and restricted funds), in case of unforeseen financial pressures. At the year end the Church held £111,556 (2022: £105,395) in the General Fund which represents approximately 10 months' expenses.

Statement of Trustees' Responsibilities

The members of the Kirk Session must prepare financial statements which give sufficient detail to enable an appreciation of the transactions of the Church during the financial year. The members of the Kirk Session are responsible for keeping proper accounting records which, on request must reflect the financial position of the Church at that time. This must be done to ensure that the financial statements comply with the Charities and Trustee Investment (Scotland) Act 2005, the Charities Accounts (Scotland) Regulations 2006 (as amended) and the General Assembly Regulations for Congregational Finance. They are also responsible for safeguarding the assets of the Church and must take reasonable steps for the prevention and/or detection of fraud and other irregularities.

DUNBARNEY AND FORGANDENNY PARISH CHURCH INDEPENDENT EXAMINER'S REPORT TO THE TRUSTEES OF DUNBARNEY AND FORGANDENNY PARISH CHURCH

I report on the accounts of the charity for the year ended 31 December 2023, which are set out on pages 8 to 13.

This report is made solely to the charity's trustees, as a body, in accordance with regulation 11 of the Charities Accounts (Scotland) Regulations 2006. My independent examination has been undertaken so that I might state to the charity's trustees those matters I am required to state to them in an independent examination and for no other purpose. To the fullest extent permitted by law, I do not accept or assume responsibility to anyone other than the charity and its trustees as a body, for my independent examination, for this report, or for the opinions I have formed.

Respective responsibilities of trustees and examiner

The charity's trustees are responsible for the preparation of the accounts within the terms of the Charities and Trustee Investment (Scotland) Act 2005 and the Charities Accounts (Scotland) Regulations 2006 (as amended).

The charity trustees consider that the audit requirement of regulation 10(1) (d) of the Accounts Regulations does not apply. It is my responsibility to examine the accounts as required under Section 44 (1)(c) of the Act and to state whether particular matters have come to my attention.

Basis of independent examiner's report

My examination was carried out in accordance with Regulation 11 of the Charities Accounts (Scotland) Regulations 2006. An examination includes a review of the accounting records kept by the charity and a comparison of the accounts presented with those records. It also includes consideration of any unusual items or disclosures in the accounts, and seeking explanations from you as trustees concerning any such matters. The procedures undertaken do not provide all the evidence that would be required in an audit, and consequently I do not express an audit opinion on the view given by the accounts.
